Dear All,

We contact you with reference to the 5th Feeder Fishing for Clubs World Championship, which will take place in Loreo, Italy, on April 9th and 10th 2022. As you know, the FIPSeD International Feeder Fishing Rules allow the possibility to register 2 Clubs per Nation, provided the following conditions are met:

“The Club World Champion of the previous year will be automatically admitted. For this reason, its Nation of belonging will be able to register a third Club, but on condition that the World Champion Club is not one of the two Clubs that qualified through the Championship played in their Country. In this case, in addition to the World Champion Club of the previous year, the Nation in question will be allowed to register only a second Club.

In each world championship for clubs, the number of second teams that may be admitted from time to time will be established on the basis of the space available on the competition venue, bearing in mind that, in addition to the previous year's World Champion Club, also the organizing nation will have the priority right for the registration of a second Club. In other words, many second Club teams will be admitted to the championship until the maximum capacity of the competition venue is reached.

To establish which second teams must be admitted as a priority, the following criteria must be followed:

- if, for example, in a competition venue the space available is sufficient to contain maximum 50 teams and there are 35 nations that intend to register 1 or 2 Clubs, a Club for each nation will be accepted as a priority (35), then the World Champion Club of previous year (1), then the second club of the organizing nation (1) and finally the 13 clubs belonging to the nations classified from 1st to 13th position of the World Championship for Clubs of the previous year;*
- In case of renouncement of one or more Clubs entitled to it, the missing Clubs must be recovered until the free places are completed, continuing in the World Championship ranking of the previous year (13th, 14th, 15th, etc.)”.*


We ask you to manifest your intention to attend the championship and, if yes, with how many Clubs (1 or 2), within the deadline of February 16th.

The respect of the deadline above (February 14th) is a necessary condition for being allowed to register 2 Clubs at the Championship in question. So, we invite all Federations to reply within this term. However, the communication of your intention to participate doesn't entail the automatic acceptance of the second Club to the Championship, considering the limited number of available places, which will be of about 50-55 places. Depending on the answers received, FIPSeD will take charge of communicating the list of accepted Clubs. We invite you to wait for this list before registering to the Clubs.

We remind you that the Club World Champion of the previous year will be automatically admitted and that the host Nation has the right to register a second Club as well.
