Information on the Lac de PANNECIÈRE :

Construction:

The PANNECIÈRE reservoir, located in the MORVAN, was commissioned in 1949. It is the oldest structure managed by the EPTB (Public Territorial Establishment of Basin) Seine Great Lakes.

Its action is determined by the rhythm of the seasons The dam type «with multiple vaults and buttresses» is adapted to the flared shape of the valley. In winter and spring, water is stored in the reservoir following a filling curve. During flood periods, additional withdrawals are made to limit the risk of downstream flooding. In summer and autumn, water is returned to the YONNE river to avoid too low a flow in the river and to allow in particular the withdrawal for the production of drinking water and the improvement of the quality of the aquatic environments. These water refunds are regulated downstream by a compensation pool of 370,000 m3 managed by EDF (French electrical company). A water intake also allows, from this basin, the supply of the Nivernais canal.

Management:

Low-flow support, which normally takes place from mid-June to the end of October, can provide an average of 5.7 m3/s of additional Yonne flow support for an average summer natural flow of 2 m3/s.

During periods of flooding, the reservoir can store a large part of the river flow, thus limiting flooding in the Yonne valley downstream of the structure. The exploitation of the reservoir is determined by a water regulation defined by inter-prefectural decree, established after consultation of the basin organisations and after a public inquiry. This regulation defines the different volumes of water that the structure must contain, as well as the minimum flow rate to be maintained in the Yonne (reserved flow rate) and the maximum flow rate not to be exceeded as far as possible (reference flow rate).

On this basis, the filling of the lake, which normally starts on 1 November, follows a curve defining monthly objectives. Filling is completed in mid-June. From mid-June to the end of October, the tank is gradually emptied. This emptying can be extended in November and December in case of very dry season. The start of filling or drawing support may vary according to the needs due to climatic hazards. The new water regulation was approved on 27 January 2015.




HOW TO GET TO THE SITE:

ANTI-DOPING INFORMATION TUE REQUESTS







The athletes participating in the Championship, with the registration, implicitly accept all WADA anti-doping rules.

Athlete whose illness or condition requires treatment with a prohibited substance or method must apply to CIPS for a Therapeutic Use Exemption (TUE) following the CIPS strict TUE application process.

He/she shall then use the application form, which can be downloaded from the ITA website: https://ita.sport/uploads/2021/02/ITA_TUE_Form.pdf

The TUE request has to be sent to the following address: tue@ita.sport

Athletes must therefore consult the Prohibited List https://www.wada-ama.org/sites/default/files/2022-09/2023list_en_final_9_september_2022.pdf

If the TUE is granted, the athlete will then be permitted to use the medication during the period of validity of the TUE without committing an Anti-Doping Rules Violation (ADRV).

Regardless of whether a TUE has been granted or not, athletes should always declare on the doping control forms filled out during sample collection any medications and supplements taken within the seven days prior to sample collection, and any blood transfusions in the three months prior for blood samples.

If a TUE has already been granted by a NADO or by a RADO, the Athlete in question does not have to apply for any additional CIPS TUE, as CIPS recognizes all TUE granted by NADOs and RADOs.










Map of the lake and the sectors for the Championship:



Unfortunately, we cannot organise official competitions before the world championship. But it is possible to train whenever you can until 7 days before the event.

Be careful if you want to train, you have to buy a fishing card to be in compliance with the legislation.

Several cards exist: a weekly card (holidays, week) or an annual card.

It's very important to select the following fishing association:

CHATEAU-CHINON (58120) (Campagne or Ville) "Château-Chinon « La truite morvandelle ».

You should also know that the legislation of the lake does not allow night fishing everywhere. There are some parts of the courses that are opened.

REGISTRATION FEES:

⇒ FIPSed tax: € 150,00

⇒ Registration fees : € 1450,00

⇒ Closing banquet (for the accompanying person): € 60,00

The registration fees include 11 closing banquets, 8 fishing cards for the entire Championship, insurance and all the related miscellaneous expenses, such as the purchase of trophies and materials required for the organisation of the Championship.

The Federations, in addition to the medals devoted to the official members of the Delegation, will be allowed to ask on place for extra medals (up to a maximum of 3 per team), upon payment of a contribution of € 25 per extra medal, which will also include the diploma. The fees for extra medals shall be paid to the organisers, who will then transfer the sum to F.I.P.S.e.d. In no case and for no reason extra medals in a number higher than that provided by these Rules may be requested from F.I.P.S.e.d.

The registration of the nations for the event will only be validated after the reception of the bank transfer and the reception of the complete registration form. These documents must be sent before July 30, 2023.

All the delegations have to bring their own national flag and national anthem. The national anthem will be verified by the organisation committee with the presence of a member of the team during registration, at the beginning of the Championship.
